**Piping:** The piping shall be marked every 5 feet (1.5 m) with the following:

- a) Manufacturer's name or trademark.
- b) Standard designation.
- c) Material designation or cell class.
- d) Nominal pipe size
- e) Type of Application "DWV" or "Sewer".
- f) Gasketed pipe shall be marked with insertion depth mark on the spigot end, as applicable.
- g) Date or date code of manufacture; and
- h) ICC-ES PMG mark of conformity.

**Fittings:** The fittings shall be marked with the following:

- a) Manufacturer's name or trademark.
- b) Size.
- c) Material designation.
- d) Standard designation, as applicable
- e) ICC-ES PMG mark of conformity (optional due to size limitation).

Installation:

Pipe and fittings must be installed in accordance with the manufacturer's published installation instructions, the applicable codes and this listing. Where differences exist, the instructions in this listing must govern.
